He needs written documentation from the IRS that we are a 501(c)(3) organization. It will be sent to him as soon as we locate it.

#### 414 Discussion

Board members had read the 414 information provided by Alyse Peterson at last month's meeting. Discussion followed regarding whether to propose an increase in library funding by the Town of Malta on the 2015 or 2016 November ballot. The consensus was to wait for 2016. Our focus for 2015 will be to promote awareness of the library services available in the Town of Malta and encourage its continued use in meeting the needs of our community.
